The Ministry of Health and Ontario Health continue to identify family medicine and primary care as the foundation of our healthcare system. We agree, so why is working in the sector growing less appealing each year to doctors, nurse practitioners and other team clinicians?

The strength of primary care shines through our family doctors and interprofessional healthcare providers. As the frontline of our healthcare system, they play a vital role in

building healthier communities through chronic disease management, health promotion, immunizations, and more. A strong, well-supported primary care system not only benefits the entire healthcare landscape—it also provides patients with consistent, ongoing care throughout their health journey.

Unfortunately, it has to be said - our team of health and administrative professionals persevere and continue to put patients above themselves, despite no wage increase in six years. Our family physicians continue to provide quality care despite escalating overhead costs and increased administrative time. All of this was exacerbated by a partnership with a family health team weakened by no base budget increase in over 10 years.

We know what's possible when governments forecast a crisis and respond effectively. The earliest days of the post-war baby boom led to an explosion in student populations; schools were built to meet the demand and the education workforce increased.

Today, the baby boomers are now the aging boomers and frequent users of the healthcare system. For this reason, family medicine and the primary care workforce are disappearing as our infrastructure crumbles. When a family doctor shortage loomed at the turn of the millennium, a new family physician revenue model was implemented and Family Health Teams were created—an innovative, team-based model that made care more accessible, collaborative, and effective. Yet investments in the solution became stagnant, and the appeal to work in family medicine is vanishing.

The need for accessible, team-based primary care has never been greater, yet the model that once helped solve a crisis—Family Health Teams—has seen little to no funding investments for over a decade. Rather than reinvesting in what virtually eliminated unattached patients in Peterborough City and County, we're seeing structural changes without first remedying the

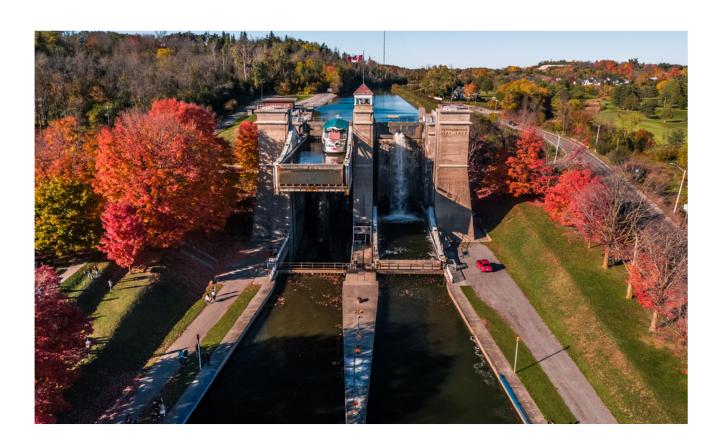
human resource crisis in primary care. Making family health teams an employer of choice with competitive salaries and more resources will be a significant incentive for physicians to choose a comprehensive family practice.

What's needed now is bold, smart investment—not just in models, but in people. In the nurse practitioners, nurses, dietitians, pharmacists, mental health professionals, and administrative staff who make high-quality, team-based care possible. This is not just an investment in a system—it's an investment in the health and well-being of our entire province.

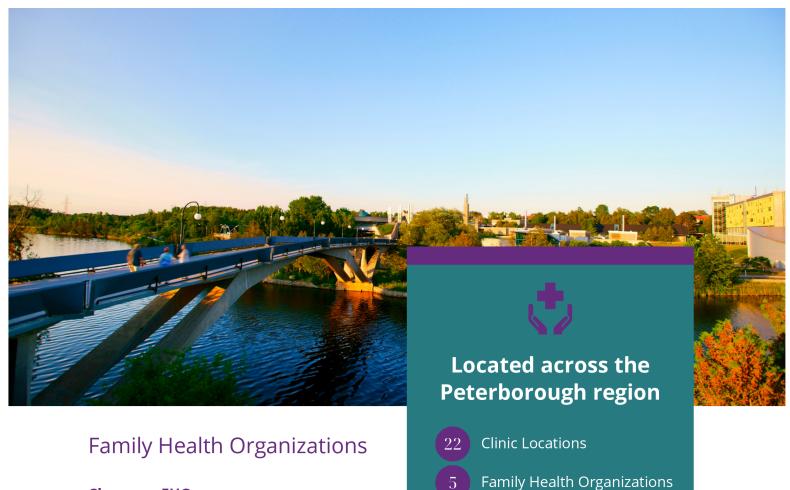

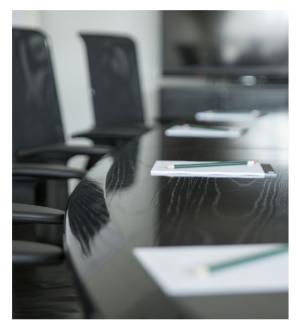

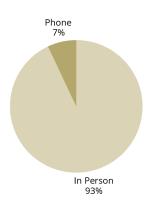

PFHT Health Clinic

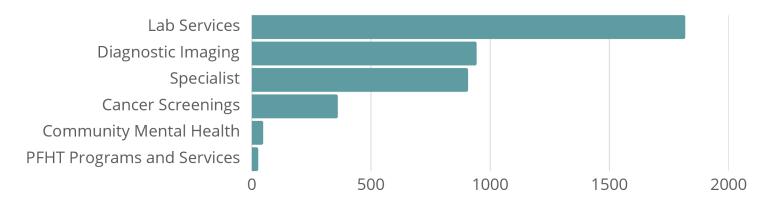


Encounters by Mode

Referrals and Connections to Community Supports and Services

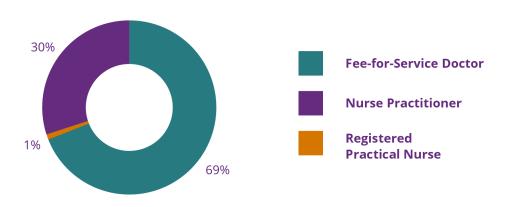


Encounters by Provider Type

Clinical Care

Well Baby Clinic



When community partners identified a critical gap in Peterborough's healthcare services, the Peterborough Family Health Team responded with a solution. The Well Baby Clinic offers timely care for infants aged two to eighteen months who lack a family physician, ensuring they meet key developmental milestones and receive essential immunization guidance.

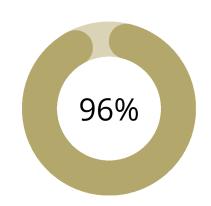

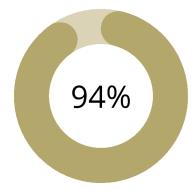
